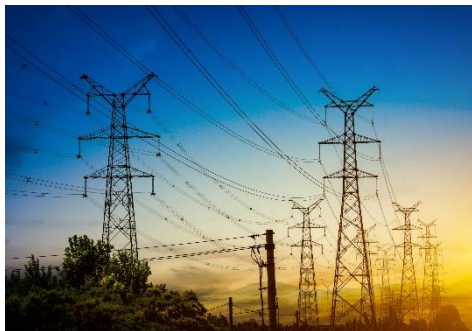

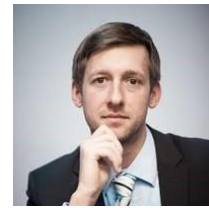

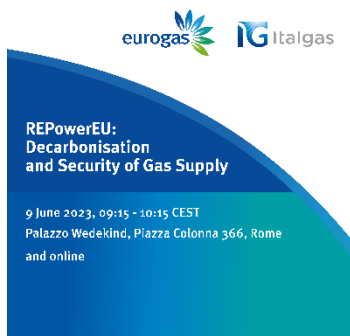


### Cogen Annual Conference 2023
