#### At the invitation of ESMIG Data protection and smart meters were on the spotlight of our last din-

Data protection and smart meters were on the spotlight of our last dinner-debate prior to the summer recess.

The European Commission is paving the way for the roll-out of smart metering systems. Smart grids will enable consumers to follow their electricity consumption in real time, saving energy and money. They should also help ensure the secure functioning of the electricity system and enable the integration of renewables. This would also allow grid operators to be able to manage the network more efficiently through the analysis of the information these provide.

Fostering the implementation of smart grids implies developing common EU-level technical standards, ensuring the highest level of data protection, adjusting the existing EU legislative framework, guaranteeing transparency and competitiveness of the retail market and finally, promoting technological innovation.

While a legal framework for the roll-out of the smart metering project has been settled in most EU countries, the debate on issues such as privacy and security is still hot.

In this regard, Frank Hyldmar, President of the European Smart Metering Industry Group commented: "At the mid-point of 2013, many countries have implemented or are ready to implement a legal framework for the roll-out. At the same time, the security and privacy topic continues to generate public interest with different dynamics emerging in individual EU member states. ESMIG understands that public acceptance is crucial to any successful Smart Meter roll-out, and thus takes the issue of security and privacy very seriously."

After the speech of Mr Hyldmar participants expressed diverse points of views that gave rise to a lively debate.
