Let's talk about costs

17 years ago, a reduction in the cost of electricity was promised thanks to the creation of the internal market. We nevertheless see the contrary happening now.

Should we blame the internal market or the 2020 targets?

This increase was to be expected since the directives on 2020 were adopted to go against market forces. Domestic consumers are now directly concerned and industries wonder what pace needs to be kept.

The report on energy prices being drafted by the European Commission is expected with great interest. Let's hope that all questions will be tackled, including the sensitive ones. It is urgent to examine the issue of price from all perspectives. As the EEF visit to the US at the end of October showed, the United States strive to reduce the cost of electricity in order to guarantee growth and exports.

The Fifth Assessment Report of the IPCC is clearly less alarming than the previous ones and many question the results of the models. It seems that now is the right time to speak about the cost of our policies not on the basis of other models but taking into account our energy bills.

A competitive and sustainable business model for 2030 and beyond

08/10/2013: Dinner-debate in Strasbourg

This debate was an occasion to discuss about the current situation of energy companies in Europe and how they are addressing economic challenges in the sector while coping with EU energy policies and environmental concerns.

During her speech, Ms. **Hege Marie Norheim**, Senior Vice President and Head of **Statoil**'s Corporate Sustainability Unit, shared some analytical insights on the role of oil and gas in the long-term sustainable energy future. She also explained how Statoil aims to maintain and develop a competitive and resilient portfolio towards and beyond 2030 by focusing on technology development, carbon-efficient operations, and by continuing to be among the world's leading suppliers of natural gas.

As Ms Hege Marie Norheim said, Statoils' response to the uncertain situation of today is "to work on our own emissions, to believe that gas has a very important contribution to make (...) and to invest in new technologies including CCS."

Delegation visit to the US : Shale Gas and Nuclear Energy 27-31/10/2013

The European Commission announces the appointment of Dominique Ristori as Director-General for Energy

The European Commission has confirmed on 6 November the appointment of **Dominique Ristori** as Director-General for Energy. He will take over in January 2014 from Philip Lowe, who will retire at the end of this year.

Mr. Ristori has been a long time supporter of our forum, showing always strong interest for a transparent dialogue between the MEPs, the Commission and the Industry. The European Energy Forum congratulates Mr. Ristori on his appointment and looks forward to a continued cooperation with him in his new duties.



Since December 2010, Mr Ristori has been Director-General of the European Union's Joint Research Centre, the Commission's in-house scientific advisory service. The EEF had the opportunity to visit the Joint Research Center facilities in Karlsruhe in October last year during one of the Parliamentary sessions in Strasbourg.

Prior to this, Mr Ristori held three senior posts in the Commission's Energy Directorate-General: Deputy Director-General (2006-10), Director in charge of general affairs and resources (2000-06), and Director in charge of European energy policy (1996-99).

Mr Ristori was born in France and he is a graduated from the Institute of Political Studies of Paris (1975).
