EEF internal meetings are crucial to the EEF work

Central in giving the guidelines for the EEF work, the internal meetings of the EEF took place between January and March. The Bureau and Board met in January and February and discussed mainly the legally statutory aspects of the association.



In February, the ITAC-Industrial and Technical Advisory Committee meeting took place. This constructive meeting allowed for an interaction between Associate Members and Board Members, reflecting and discussing on the past and working together to further improve the EEF events. Both MEPs and Industry representatives outlined the need to organise joint events with several hosts, presenting complementary views.



When the General Assembly met in March, they carefully went trough all proposals for events received from the members and established a list of topics to be presented by EEF associate Members in





the autumn programme.

The General Assembly asked the Associate Members to form alliances to host jointly an event on a particular topic, thus showing the wide variety of points of views and the complementarity.

Topics to be presented are:

- Decarbonisation of heating
- Decarbonisation of transport
- Decarbonisation of electricity
- Circular economy in different sectors
- Low carbon solutions, research, presentation of different gas options
- Role of gas Infrastructure operators, design of the gas market
- International dimension: Ukraine, Mediterranean, North Africa, Western Balkans

As always, the EEF focuses on organising informative and educational events. In addition to dinner-debates, the EEF will resume organising briefing dedicated especially to the assistants of newly elected MEPs. Visits will resume in 2019. A cooperation with the EIF could be considered for issues involving data protection, cyber security, energy grids.

The Secretariat is working on the proposals and will finalise the list of events in the coming weeks in order to present a complete programme to newly elected MEPs at our reception of 2nd July in Strasbourg.

All members proposals will not fit in our autumn 2019 programme but 2020 is just around the corner!
