DIMETA becomes Associate Member of the EEF

Dimeta is a joint venture between SHV Energy and UGI International to advance the production and use of Renewable and Recycled Carbon DME, a low-carbon sustainable liquid gas, to accelerate the LPG Industry's transition to Net Zero. By working with partners, Dimeta is developing Renewable & Recycled Carbon DME production plants, targeting a total production capacity of 300kt per year by 2027. The UK was announced as the first plant location in 2022, with subsequent plants already in development in Europe and the USA.
